#### REFUSAL ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 BAREILLY COLLEGE, BAREILLY COLLEGE, PO- SHYAMGANJ, BAREILLY-243005 had applied for grant of recognition (UP-2153) for M.ED. Course of one year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 113th meeting held on 18th 19th January, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a conditional recognition and asked the institution to appointment of faculty /staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as per prescribed under rules. The institution is required to send a letter for nomination of subject expert by the University.
- 4. AND WHEREAS the applicant institution has not submitted reply of the above said order. The matter was placed before Northern Regional Committee in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> 24<sup>th</sup> May, 2009. The committee observed that:-
  - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- NOW THEREFORE grant of recognition to BAREILLY COLLEGE, BAREILLY COLLEGE, PO-SHYAMGANJ, , BAREILLY-243005 for the course in M.ED. in term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.
