**REFUSAL ORDER**

WHEREAS in terms of Section **15(1)** of the NCTE Act, 1993 **BAREILLY COLLEGE,, BAREILLY COLLEGE,, PO- SHYAMGANJ,, , BAREILLY-243005** had applied for grant of recognition (U/P-2153) for M.Ed. Course of one year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 113<sup>th</sup> meeting held on 18<sup>th</sup> – 19<sup>th</sup> January, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a conditional recognition and asked the institution to **appointment of faculty /staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as per prescribed under rules. The institution is required to send a letter for nomination of subject expert by the University.**

4. AND WHEREAS the applicant institution has not submitted reply of the above said order. The matter was placed before Northern Regional Committee in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> – 24<sup>th</sup> May, 2009. The committee observed that:-

- **The list of appointed Faculty as per NCTE Norms has not been submitted till date.**

5. NOW THEREFORE grant of recognition to **BAREILLY COLLEGE,, BAREILLY COLLEGE,, PO-SHYAMGANJ,, , BAREILLY-243005** for the course in M.Ed. in term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.
