WHEREAS, the SHREE BALAJI DEGREE COLLEGE, VPO- KURALT, POST JANIKHURD, DISTT. MEERUT, U.P. was granted recognition for running M.Ed course of
one year duration with an annual intake of 25 students vide this office order no.
F.NRC/NCTE/F-3/UP-2743/2008/66430-36 dated 02.12.2008.

- 2. AND WHEREAS, the inspection of the institution was conducted on 26.05.2009 under section 17 of the NCTE Act 1993. Northern Regional Committee in its 142nd meeting held on 14th -16th June, 2009, after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a Show Cause Notice on 23.06.2009 to the applicant institution under provision to section 17 of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 3. AND WHEREAS the applicant institution has submitted representation on 06.10,2009. The original file of the institution as well as other documents and VTR were again duly considered by Northern Regional Committee in its 150^{th} meeting held on $09^{th}-11^{th}$. October, 2009 which came to the conclusion that recognition to the said institution be withdraw for the following reasons:
 - · Reply is not satisfactory
 - · Deficiencies still exist
- Hence, the committee decides to withdraw recognition to M.Ed. from the academic session 2010-2011. The affiliating university may be informed accordingly.
- 5. NOW THEREFORE grant of recognition SHREE BALAJI DEGREE COLLEGE, VPO-KURALI, POST - JANIKHURD, DISTT. MEERUT, U.P for the course in M.ED. in term of section 17 of the NCTE Act, 1993 is hereby withdraw.

If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
