ORDER

WHEREAS in terms of Section 14(1) of the NOTE Act, 1993 Gandhi Faiz- E- Aam College, Shahjahan Pur, U.P., had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting B.Ed Course of One year duration with an annual intake of 100 (One Hundred Only) students on 28.12.2005.

- AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 109th 2nd Sitting and 110th Meeting held on 11th to 12th November 2006 the committee decided to issue Conditional Letter of Recognition to the institution and accordingly conditional recognition order was issued vide NCTE latter no. F.NRC/NCTE/F-7/8314-39 Pated 14.11.2006.
- AND WHEREAS the applicant institution did not comply with the direction given in the order dated 14.11.2006 the matter was placed before NRC in its 141st Meeting held on 22st to 24th May 2009 and the committee decided to refuse the recognition for 8,ED Course of one year duration on the ground that the list of appointed faculty as per NCTE Norms has not been submitted by the Institution till date. Accordingly order was issued vide order no. F.NRC/NCTE/F73/UP-2025/141 MEETING/2009/8261-67 dated 18.08.2009. The above said institution, thereafter preferred an appeal dated 16.08.2009 to the NCTE, New Delhi, Under section 18 of the NCTE Act 1993 against the aforesald order,
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral 4. arguments advanced during the hearing, the NCTF, New Delhi, reached the conclusion that there was adequate ground to accept the appeal, and accordingly remanded back the matter to NCTE NRC with the direction to grant recognition to the institution in continuation to conditional recognition order dated 14.11.2006 so as to restore the recognition of the institution, in its order no. F.NO. 89-866/2009 -APPEAL dated 08,10,2009.
- AND WHEREAS the matter was placed before the NRC NCTE in its 151* Meeting held on 20th to 21th October 2009 and the committee decided process the file as directed.
- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NOTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to Gandhi Faiz- E- Aam College, Shahjahan Pur, U.P. for conducting B.Ed Course of Secondary (Level) of One year duration with an annual intake of 100 Students (One Hundred only) students in continuation to conditional recognition order dated 14.11.2006 so as to resture the recognition of the institution.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern
- The institution shall compty with the various other norms and standards prescribed in the NCTE regulations, as amended from time to this.

- 11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- 12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as supulated provisions of Section 17(1) of the NCTE Act.
- 13. The Institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - · Land and Building Particulars
 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.
- 14. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated type.
