REFUSAL ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, RAMRAZI DEVI MAHILA MAHAVIDVALYA, SATHIYAV, DISTT. - AZAMGARH, U.P. had applied for grant of recognition (UP-1306) for BTC. Course of 2 year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

- AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 104st meeting held on 15th 17th July 2006. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of conditional recognition and asked the institution to Appoint duly selected staff with the requisite qualification as per NCTE Norms and Standard and inform the Regional Committee.
- 4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed before Northern Regional Committee in its 141s meeting held on 22nd 24th May, 2009. The original file of the institution along with all other related documents, affidavits Act of NCTE 1993, Regulations and Guidelines of NCTE published from time to time etc. were considered and the committee observed that:-
 - The list of appointed Faculty as per NCTE Norms has not been submitted till date.
- 5. Hence, the committee decides to refuse recognition and return FDRs if submitted
- 6 NOW THEREFORE grant of recognition to RAMRAZI DEVI MAHILA MAHAVIDYALYA, SATHIYAV, DISTT. AZAMGARH, U.P. for the course in BTC. in term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.
