ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 R.S.M.P. Degree College, Vill- Rail Askaranpur, Post- Badganwa, Tehsil- Kunda, District- Pratapgarh, Uttar Prades. had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting B.Ed Course of One year duration with an annual intake of 100 (One Hundred only) students on 18.10.2007.

- 2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the Institution along with VTR videography were duly considered by the NRC in its 138th accordingly clarification letter was issued vide letter no. F.NRC/NCTE/F-3/UP-2658/138
- 3. AND WHEREAS the applicant institution has submitted representation to Northern Regional Conventue, NCTE, Jaipun on 15.04.2009 and the matter was placed before NRC in its 139th Meeting held on Loth to 12th April, 2009 and the committee decided to refuse the recognition for B.ED course of one year duration. Accordingly order was issued to the institution vide order no. F.NRC/NCTE/F73/UP-2658/139 dated 11.06.2009 to the NCTE, New Delhi, under section 18 of the NCTE Act 1993 against the aforesaid order.
- 4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal, and accordingly remanded back the matter to NCTE NRC with the direction to issue the order of recognition to the institution, vide its order no. F.NO. 89-544/2009 -
- 5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to R.S.M.P. Degree College, Vill- Rel Askaranpur, Post- Badganwa, Tcheil- Kunda, District- Pratapgarh, Uttar Pradesh for conducting L.ED course of Secondary (Level) of One year duration with an annual intake of 100 Students (One Hundred only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S) dated 01/10/2009:
 - The admissions of students shall be made only after affiliation by the examining body shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
 - Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be aperated along with an officer of the Northern kegional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE.
