## ORDER

WHEREAS Lata Amichand Monga Memorial Education Trust, VPO - Ugala Tehsil - Barara, Dist. Ambala, Haryana had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition / permission for starting M.Ed. course one year duration on 30.12.2005.

- 2. AND WHEREAS in its 107<sup>th</sup> meeting held on 26<sup>th</sup> 27<sup>th</sup> August 2006 Northorn Regional Committee after considering the report of the visiting team as well as other relevant meterials furnished by the applicant institution had decided to issue a conditional Recognition order and ask the Institution to appoint staff by a duly constituted selection committee with the requisite qualification as per Norms and Standards of NCTRF and affiliating University and Inform the Regional Committee by sending signed copy of the minutes alongwith an Affidavir. Accordingly letter of intent prior to recognition was issued to the Institution on 27.8.2006.
- 3. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 143<sup>rd</sup> meeting held on 27-29<sup>rd</sup> August 2006. The original file of the institution, alongwith all other related documents, attidavits, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time, etc. were considered and Northern Regional Committee and Committee had decided to refuse recognition for bits. Course. Accordingly, Refusal order has been issued on 16.7.2009.
- 4. AND WHEREAS the applicant institution has preferred an appeal on 27.07.2009 against the Refusal order of NRC dated 16.7.2009 to the appellate authority. The appeal of the institutions was accepted, order dated 16.07.2009 of the NRC set aside with direction to the NRC to grant recognition to the institution, in continuation to the earlier recognition order dated 27.8.06, within 15 days vide order dated 08.10.2009.
- 5. AND THEREFFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to Lula Amichand Monga Memorial Education Trust, VPO Ugala Tehell Barara, Dist. Ambala, Haryana for conducting B.Ed. Course of one year duration with an annual intake of 100 (one hundred only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulations, 2007 notified on 10.12.2007 subject to fulfillment of the following conditions as per the clanification from NCTE HQtrs letter No. file No. 48-3(1)/2008/NCTE/(N&S) dated 01.10.2009.
  - The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off data prescribed by the examining body for the academic session 2009-2010, falling which the recognition will be effective from the academic session 2010-2011 only.
  - II. Formal orders for recognition / permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating body.
- The institution shell, within one month of the receipt of recognition under, convert the endowment fund and Reserve fund account into a joint account to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause B(12) of the NCTE Regulation, 2007 notified on 10.12.2007.

- 10. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTF for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- II. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- 12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act
- 13. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

(I) Copy of the Application Form

(ii) Land and Building Particulars

(III) Staff Profile

(iv) Recognition letter

- (v) Information for having fulfilled the norms 8 standard and other required conditions.
- 14. In case if the land is in the name of the Society, you must transfer the land within six months in the name of institution failing which action shall be initiated to withdraw the recognition. It shall be essential on part of the institution concerned to g of the needful done in this regard and intimate the respective Regional Committee alongwith the new land documents within stipulated time.
