REFUSAL ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **INSTITUTE OF LAW & ACADEMIC STUDIES , E-211, KAVI NAGAR INDUSTRIAL AREA, SECTOR - 17, GHAZIABAD, UTTAR PRADESH** had applied for grant of recognition (UP-1321) for BTC. Course of two years duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 123rd meeting held on 19th - 22nd November, 2007. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a conditional recognition and institution be directed to submit Affidavit on Rs. 100/- stamp paper from the Management of the institution about the staff on the prescribed format, Affidavit on Rs. 10/- stamp paper from each staff member on the prescribed format & attested copies of degree and experience certificated in respect of all the staff and principal.

4. AND WHEREAS the applicant institution has not submitted reply of the above said order. The matter was placed before Northern Regional Committee in its 141st meeting held on 22nd - 24th May, 2009. The committee observed that:-

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. NOW THEREFORE grant of recognition to **BAREILLY COLLEGE,, BAREILLY COLLEGE,, PO- SHYAMGANJ,, , BAREILLY-243005** for the course in M.ED. in term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.
