**REFUSAL ORDER**

WHEREAS SHRI BABOO LAL MAHAVIDYALAYA, BARSANA ROAD, GOVERDHAN, MATHURA, U.P., of recognition (UP-2778) for B.ED Course of One years (1) duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 28.12.2007.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 145<sup>th</sup> Meeting held on 26<sup>th</sup> to 28<sup>th</sup> July 2009, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the committee decided to issued letter under clause 7(11) of Regulations 2007 subject to developing Website as per NCTE Norms to the applicant institution on 31.07.2009.

4. AND WHEREAS the applicant institution not submitted representation to Northern Regional Committee, NCTE. The matter was again placed before the NRC in its 150<sup>th</sup> Meeting held on 09<sup>th</sup> to 11<sup>th</sup> October 2009 and the committee observes that:

- The institution did not respond to the NRC, NCTE letter dated 31.07.2009 till date.

5. AND WHEREAS Hence, the committee decides to refuse recognition to B.ED Course.

6. NOW THEREFORE grant of recognition to SHRI BABOO LAL MAHAVIDYALAYA, BARSANA ROAD, GOVERDHAN, MATHURA, U.P. for the course in B.ED course in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. 5.00 Lakhs bearing no. 0914112 & FDR of Rs. 3.00 Lakhs bearing No. 0914111 are returned herewith.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
