ORDER

WHEREAS, the ASTER COLLEGE OF EDUCATION, J-1, SECTOR - 9, DELTA-II, GREATER NOIDA, DISTRICT - G.B.NAGAR, UP. Was granted recognition for running B.Ed. course of one year duration with an annual intake of 200 students vide office order no. F. NRC/NCTE/F-3/UP-1064/8187-8195, dated 24.01.2004.

- 2. AND WHEREAS, in order to ascertain, whether the institution is functioning in accordance with the provisions of NCTE Act, the NCTE Hqtrs Delhi Conducted inspection U/S-13 of the NCTE Act, 1993 and rule 8 of the NCTE Rule 1997 to the institution namely Aster College of Education, J-1, Silver Oak Estate, Sector -9, Delta -II, Greater Noida, UP. On 1ST August, 2006.
- 3. AND WHEREAS, the NCTE Hqtrs vide its letter NO. F.NO.93 (UP)-100/2006/Insp./NCTE/61808 date December 29,2006 observed that the deficiencies communicated in the VT Report are serious in nature and violates NCTE norms and communicated their observation to NRC, NCTE, Jaipur to take appropriate action under section 17 of the NCTE Act ,1993.
- 4. AND WHEREAS the above observation was placed before NRC in its 137" Meeting held on 28" Feb and 1" March, 2009 and committee decided to issue show cause notice under section 17 of NCTE Act, 1993 on the basis of observations and comments of the VT report given in the inspection report conducted under section 13. Accordingly Show Cause Notice was issued to the institution on 30.03.2009.
- 5. AND WHEREAS the applicant institution submitted its reply on 02.04.2009. The original file of the institution as well as other documents and reply dated 02.04.2009, considered by Northern Regional Committee in its 141^{41} meeting held on $22^{nd} 24^{th}$ May, 2009 which come to the conclusion that recognition to the said institution be withdrawn for the following reasons:
 - From the reply submitted by the Institution, it is clear that the
 deficiencies pointed out on the basis of Inspection conducted under
 section 13 exist. The reply submitted by the Institution is not found
 to be satisfactory.
