**REFUSAL ORDER**

WHEREAS in terms of Section 15(I) of the NCTE Act, 1993 MILESTONE INSTITUTE OF PROFESSIONAL STUDIES, DELHI, MEERUT ROAD, MORTA, GHAZIABAD, UTTAR PRADESH had applied for grant of recognition (UP-2686) for M.ED. Course of one year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 131<sup>st</sup> (3<sup>rd</sup> Sitting) meeting held on 29<sup>th</sup> - 31<sup>st</sup> August 2008. The Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to issue a letter of intent prior to recognition and asked the institution to **appointment of faculty /staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as per prescribed under rules, along with an Affidavit on the prescribed format on Rs. 100/- stamp paper from the Management of the institution is required to be submitted and the institution shall launch its own website covering, interalia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure, instructional facilities and the particulars of their proposed teaching and non-teaching staff etc. Accordingly letter of intent prior to recognition was issued to the institution on 04.09.2008 and a clarification letter was issued on 01.10.2008.**

4. AND WHEREAS the applicant institution has not submitted proper reply. The matter was placed before Northern Regional Committee in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> - 24<sup>th</sup> May, 2009. The original file of the institution along with all other related documents, affidavits Act of NCTE 1993, Regulations and Guidelines of NCTE published from time to time etc. were considered and the committee observed that:-

- The deficiencies pointed out in letter dated 01<sup>st</sup> October, 2008 have not been met.

5. NOW THEREFORE grant of recognition to MILESTONE INSTITUTE OF PROFESSIONAL STUDIES, DELHI, MEERUT ROAD, MORTA, GHAZIABAD, UTTAR PRADESH for the course in M.ED. in term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.
