**REFUSAL ORDER**

WHEREAS ROYAL EDUCATIONAL INSTITUTE, 28<sup>TH</sup> K.M. STONE, NH - 24, DELHI - HAPUR BYEPASS, DASNA, GHAZIABAD, UP. had applied for grant of recognition (UP-2037) for B.ED. COURSE one years(s) duration under section 14 (1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

3. AND WHEREAS in its 112<sup>TH</sup> meeting held on 27<sup>th</sup> and 28<sup>th</sup> December 2006, at NCTE Hqrs New Delhi considered application of the institutions included in the Agenda for the meeting and after careful examination of relevant documents, replies received from the institution, Visiting Team Reports, Video Recording, Original file etc. as per the case found the institutions fit for grant of condition recognition of the B.Ed. Course subject to condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./ Affiliating University/Body given effect before the commencement of the course etc. Accordingly order was issued to the institution on 29.12.2006.

4. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> - 24<sup>th</sup> May 2009. The original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee observes that:

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.

5. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant recognition to ROYAL EDUCATIONAL INSTITUTE, 28<sup>TH</sup> K.M. STONE, NH - 24, DELHI - HAPUR BYEPASS, DASNA, GHAZIABAD, UP. for the course in B.ED. is hereby refused.
