ORDER

WHEREAS **Krishna College of Science & Information Technology, Noorpur Road, Bijnor, U.P.**, of recognition (UP-2170) for **B.ED Additional Intake** of One years (1) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **17.08.2006**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 112<sup>th</sup> Meeting held on **27<sup>th</sup> to 28<sup>th</sup> December 2008**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the committee decided to issued conditional recognition to the applicant institution on **29.12.2006** and clarification letter issued on **05.02.2008**

4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE. The original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its **141<sup>st</sup> Meeting** held on **22<sup>nd</sup> to 24<sup>th</sup> May 2009** and the committee observes that:

- The list of appointed faulty as per NCTE norms has not been submitted till date.

5. AND WHEREAS the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to **Krishna College of Science & Information Technology, Noorpur Road, Bijnor, U.P.** for the course in **B.ED Additional Intake** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. 5.00 Lakhs bearing no. **416445** is returned herewith.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
