November, 2006 and 11th 12th November, 2006 at NCTE Hqrs, New Delhi, considered application of the institutions and after careful examination of relevant documents, Visiting Team Reports, Video Recording, Original file etc. found the institutions fit for grant recognition of the B.P.ED.
