REFUSAL ORDER

WHEREAS In terms of Section 14(1) of the NCTE Act, 1993 KARGIL SHAHEED MAHAVIDYALAYA, KACHAURA ROAD, JASWANT NAGAR, ETAWAH, U.P. had applied for grant of recognition (UP-1594) for BTC Course of Two year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 03.11.2004.

2. AND WHEREAS the Competent authority has constituted a Visiting Team to Visit the Institution and the visiting team had since submitted its report,

3. AND WHEREAS in its 101st meeting held on 22nd to 24th February 2006 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and the committee decided to issue a letter of conditional Recognition on 26.08.2006 to the applicant institution under proviso to section 15(3) (b) of the NCTE Act, 1993.

4. AND WHEREAS the applicant institution has not submitted the representation to the NRC NCTE, Jaipur and the matter was again placed before the committee in its 141st Meeting held on 22nd to 24th May 2009 and the committee decides:-

- The list of appointed Faculty as per NCTE Norms has not been submitted till date.
5. AND WHEREAS, the committee decides to refuse recognition and return FDRs if submitted.

6. NOW THEREFORE grant of recognition to KARGIL SHAHEED MAHAVIDYALAYA, KACHAURA ROAD, JASWANT NAGAR, ETAWAH, U.P for the course in BJC. In term of section 15(3) (b) of the NCTE Act, 1993 is hereby refused.

7. If the Institution is not satisfied by the above order they may prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
