

## ORDER

WHEREAS District Institute of Education and Training, Etawah, U.P., of recognition (UP-1971) for BTC of Two years (2) duration under section 14(1) of the NCTE Act, 1993 (a the Northern Regional Committee, NCTE on 03.01.2005.

- AND WHEREAS the competent authority had constituted a Visiting Toam to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS in its 137th Meeting held on 28th Feb to 1st March 2009, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, and the committee decided to issue a clarification letter to the applicant institution. Accordingly the letter was issued by this affice letter no. F.NRC/NCTE/F-7/UP-19-1/2009/71134 dated 12.03.2009.
- 4. AND WHEREAS the applicant institution has not submitted the reply to the Northern Regional Committee, the matter was again placed before the NRC in its 149<sup>th</sup> Meeting held on 13<sup>th</sup> to 14<sup>th</sup> September, 2009 and the committee observes that:
  - The Institution has not responded to NRC, NCTE letter dated 12
    March 2009 till date.
- 5 AND WHEREAS Hence the committee decides to refuse recognition to 3TC Course.
- NOW THEREFORE grant of recognition to Distric: Institute of Education and Training, Etawah, U.P. for the Gurse in BTC Course in crm of section 14(3)(b) of the NCTE Act, 1993 is hareby refused
