ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Amity University, Department of Education, Plot No. 4, Sector-125, Noida, District- G.B. Nagar, U.P. had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting **B.P.Ed Course** of **One year** duration with an annual intake of **50 (Fifty Only)** students on **30.12.2005**.

2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 100th Meeting (Second Sitting) and 110th Meeting on 10th November, 2006 and 11th to 12th November, 2006 at NCTE HQrs, the committee decided to issue Conditional recognition subject to appointment of faculty members as per NCTE Norms and accordingly order was issued to the institution vide NCTE letter no. **F.NRC/NCTE/F-7/8371-79 dated 14.11.2006**.

3. AND WHEREAS the applicant institution did not submit staff profile as per NCTE Norms and hence the matter was placed before NRC in its 141st Meeting held on 22nd to 24th May 2009 and the committee decided to refuse the recognition for B.P.ED course of one year duration. Accordingly order was issued vide order no. **F.NRC/NCTE/F73/UP-2051/141 MEETING/2009/5921-27 dated 09.07.2009**. The above said institution, thereafter preferred an appeal dated 31.07.2009 to the NCTE, New Delhi, Under section 18 of the NCTE Act 1993 against the aforesaid order.

4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal, and accordingly remanded back the matter to NCTE NRC for issue of a revised order specifying that the withdrawal of conditional recognition accorded to the institution NRC Order No **F.NRC/NCTE/F-7/8371-79 dated 14.11.2006 would be effective from the academic session 2010-2011** vide order no. **F.NO. 89-926/2009 -APPEAL dated 08.10.2009**.

5. NOW, THEREFORE, in exercise of the powers vested under Section 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraw the conditional recognition accorded to the institution vide NRC Order No **F.NRC/NCTE/F-7/8371-79 dated 14.11.2006** and the same would be effective from the academic session 2010-2011.
