WHEREAS SARASWATI COLLEGE OF EDUCATION, C/O M/S SHIV BHOLEY ROLLER, FLOUR MILLS

(P) MILLS, 5th KM STONE, DABRA ROAD, HISSAR - 125005, HARYANA had submitted an application to the Northern Regional Committee of NCTE, laiper for grant of recognition / permission for starting (HR-344) for B.Ed. course are years (1) direction with an annual intake of 188 (Hundred Only) students on 02.01.7006

- 2. AND WHEREAS in its 167th meeting held on 26th to 27th August 2006 the Northern Regional Committee after considering the report of the visiting feam as well as other relevant materials furnished by the applicant institution, had decided to issue a letter of conditional recognition and ask the institution to appoint shift by a duly constituted selection committee with the requisite qualification as per Norms and Standards of NCTs and affiliating body and inform the Regional Committee y sending signed copy of the minutes alongwith an Allitavit. Accordingly a letter of conditional recognition was issued on 27.8.2006.
- AND WHEREAS the applicant institution had not submitted representation to the Northern Regional Committee, NCTE. The matter was pluced in 141" meeting held on 22" to 24" May 2009. The Committee had decided to withdraw the conditional recognition granted to the institution. Accordingly withdrawal order was issued on 16.6,2009.
- 4. AND WHEREAS the institution had preferred on appeal on tils.06.2009 against the withdrawal order of NRC dated 10.6.2009 to the appealate authority. The appeal of the institutions was accepted and NRC's order dated 10.6.2009 was set aside with direction to NRC to grant recognition to the institution immediately vide order dated 29.9.2009.
- 5. AND THEREFFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to SARASWATI COLLEGE OF EDUCATION, C/O M/S SHIV BHOLEY ROLLER, FLOUR MILLS (P) MILLS, 5" KM STONE, DABRA ROAD, HISSAR 125005, HARYANA for conducting 8.Ed. Course of Secondary Level of one year duration with an annual intake of 100 (One Hundred Only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulations, 2007 notified on 10.12.2007 subject to fulfillment of the following conditions as per the clarification from NCTF HQtrs letter No. file No. 48-3(1)/2008/NCTE/(NRS) doted 01.10.2009.
 - I. The admissions of students shall be made only after affiliation by the examining body before the communicament of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.

 Formal orders for recognition / permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affillating body.

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and Reserve fund account into a joint account to be operated along with an ufficer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulation, 2007 notified on 10.13.2007.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory todies like UGC, the State Government etc.

A copy of the format is enclosed with the order.
- 11. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain 8 update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure;

(i) Copy of the Application Form

(a) Land and Building Particulars

(iii) Staff Profile

(iv) Recognition letter

- Information for having fulfilled the norms & standard and other required conditions.
- 13. In case if the land is in the name of the Society, you must transfer the land within aix months in the name of institution failing which action shall be initiated to withdraw the recognition. It shall be essential on part of the institution concerned to g et the needful done in this regard and intimate the respective Regional Committee alongwith the new land documents within stipulated time.
