WHEREAS IN terms of Section 14(1) of the NCTE Act, 1993 RAJEEV MEMORIAL INSTITUTE OF EDUCATION AND TECHNOLOGY, BHARDWAJFARM HOUSE, GANGOH, SAHARANPUR, U.P. has submitted an application (code No. APN06062) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. course of One year duration with an annual intake of 100 (one Hundred ) students on

- 2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and ideography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the <u>Secondary teacher education Programme</u> such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the Programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Soction 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to RAJEEV MEMORIAL INSTITUTE OF EDUCATION AND TECHNOLOGY, BHARDWAJFARM HOUSE, GANGOH, SAHARANPUR, U.P. for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (One Hundred) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007.
- 4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause B(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- Further, the recognition is subject to fulfillment of all such other requirements as
  may be prescribed under relevant norms and standards of NCTE for other regulatory bodies
  like UGC, the State Government etc. wherever applicable.
- 8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

Hence, it is required that the land is to be registered in the name of the institution on ownership basis i.e. bainama, sale deed gift deed within six months falling to which recognition stands cancelled automatically.
