ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Vinayak Vidyapeeth, NH - 58, Vill - Pawli Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting B.Ed Course of One year duration with an annual intake of 100 (One Hundred Only) students on 23.05.2008.

- 2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videograph were duly considered by the NRC in its 144th Meeting held on 12th to under clause 7(9) of Regulations 2007 was issued vide NCTE letter no. F.NO.NRC/NCTE/F-7/UP-3015/144 meeting/2609/6694-95 Dated 23.07.2009.
- 3. AND WHEREAS the applicant institution submitted representation to Northern Regional Committee, NCTE on 27.07.2009 and the matter was placed before NRC in its 146th Meeting held on 05th to 07th August, 2009 and the committee decided to refuse the recognition for B.ED Course of one year duration. Accordingly order was issued vide order no. F.NRC/NCTE/F-7/UP-3015/146 Meeting/2009/10199-10205 dated 10.09.2009. The above said institution, thereafter preferred an appeal dated 31.08.2009 to the NCTE, New Delhi. Under section 18 of the NCTE
- 4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal and that it should be accepted, Accordingly, the appeal was accepted and NRC's decision dated 05 07 August, 2009 was reversed with a direction to NRC to issue formal recognition within 15 days of issue of this order.
- 5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Vinayak Vidyapeeth, NH ~ 58, Vill Pawli Khas, Post Modipuram, Distt. Meerut, Uttar Pradesh for conducting B.Ed Course of Secondary (Level) of One 2009-2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions as per the clarification from the NCTE HQtrs letter No. File No. 48-3(1)/2008/NCTE (N&S)
 - I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
 - II. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating
- 6. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional
- The institution shall comply with the various other norms and standards prescribed in the NCTE

- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as
