- AND WHEREAS the competent authority had constitute a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS in its 138th Meeting held on 14th March to 15st March, 2009 the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 25.03.2009 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
- 4. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE.. The facts of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 141st Meeting held on 25th April to 26th April, 2009 the committee decided that recognition to the said institution be refused for following reasons.
 - The difficienceies communicated to the institution in the show cause notice were not removed in the stipulated time.
- 5 AND WHEREAS the committee decides to refuse recognition and retuen FDRs if submitted.
- 6. NOW THEREFORE grant of recognition to POORVA COLLEGE OF EDUCATION, VILLAGE- MUNDLANA, POST- MUNDLANA, TEHSHIL- SONEPAT, DISTT- SONEPAT, HARYANA for the course in B.Ed in term of section 14(3)(b) of the NCTE Act, 1993 is bereby refused. FDR of five lack vide no 510530 and FDR of three lack vide no 510857 are returned herewith.
