ORDER

WHEREAS in terms of Section **14(1)** of the NCTE Act, 1993 **Guru Dronacharya College of Education, Vill-Dhani Kirarod, Post-Dharsu, Teh-Narnaul, Mohindergarh, Haryana**, has submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **B.Ed Course of One year** duration with an annual intake of **100 (Hundred only)** students on **10.01.2008**.

2. AND WHEREAS the matter was placed in 141<sup>st</sup> Meeting held on 22<sup>nd</sup> -24<sup>th</sup> May 2009. The committee after considering the application and reply submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, was satisfied that the applicant institution does not full fill the requirements and has decided to refuse recognition of the institution. Accordingly, Refusal order was issued vide order No. **F.NRC/NCTE/F-7-3/HR-1389/2009 dated 29.05.2009**.

3. AND WHEREAS the institution has preferred an appeal on **09.06.2009** against the refusal order of NRC dated **29.05.2009** to the appellate authority. The appeal of the institution was accepted and NRC's order dated **29.05.2009** was set aside by the appellate authority with direction to the NRC to grant recognition to the institution immediately vide order dated **07.08.2009**.

4. NOW, THEREFORE, in exercise of the powers vested under Section **14(3) (a)** of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to **Shree Guru Dronacharya College of Education, Vill-Dhani Kirarod, Post-Dharsu, Teh-Narnaul, Mohindergarh, Haryana**, for conducting **B.Ed of Secondary (Level)** of **One year** duration with an annual intake of **100 (Hundred only)** students from the academic session **2009-2010** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007.

5. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

6. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

7. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

8. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

10. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
11. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
- Copy of the Application Form
  - Land and Building Particulars
  - Staff Profile
  - Recognition letter
  - Information for having fulfilled the norms & standard and other required conditions.
12. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
