### **ORDER**

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 Rudra Institute of Technology, Village – Mawana Khurd, Post – Mawana, Tehsil – Mawana, District – Meerut, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of one year duration with an annual intake of 100 (One Hindered Only) students on 31.10.2008.

AND WHEREAS, as per decision taken by NRC in its 140<sup>th</sup> meeting application was rejected vide order dated 05.06.2009. The institution had preferred an appeal before the Council under section 18 of NCTE, Act, 1993 against the order of NRC. The order of NRC was set – aside by the Council vide order dated 29.09.2009 with direction to NRC for inspection of the Institution immediately. The inspection of the said Institution was conducted on 12.01.2010.

AND WHEREASE, the visiting report was placed before NRC in its 155<sup>th</sup> Meeting held from 23<sup>rd</sup> to 25<sup>th</sup> January, 2010 & as per the decision of NRC, recognition was refused vide order dated 29.01.2010.

AND WHEREASE, the institution had preferred an appeal before the Council under section 18 of NCTE, Act, 1993 against the order of NRC. The order of NRC was set – aside by the Council vide order dated 10.03.2010 with direction to NRC for re-examination of the VTR and other related documents and take further decision on merit. The case was considered by NRC in its 157<sup>th</sup> meeting and as per the decision of NRC, show cause notice was issued vide letter dated 12.04.2010.

AND WHEREAS, the show cause reply was placed before NRC, in its 161st Meeting held from 26th to 29th May, 2010 & it was decided that VT be sent to verify the deficiencies met.

AND WHEREAS, the reply of the institution was considered by NRC in its 169<sup>h</sup> Meeting held from 12<sup>th</sup> and 13<sup>th</sup> October, 2010 in view of the order of Hon'ble High Court of Allahabad dated 20/09/2010 and as per the decision of NRC,letter under clause 7(9) of regulations 2009 was issued to the institution on 10/11/2010.

AND WHEREAS, the reply of the institution dated 07.12.2010 and the original file was considered by NRC in its 174<sup>th</sup> meeting held from 08<sup>th</sup> to 10<sup>th</sup> December, 2010 and Committee decided that the recognition for 100 seats in B.ED. course under clause 7(11) of NCTE Regulation, 2009 be granted to the Institution subject to the following condition:-

- i) The admission of the students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- ii) Formal recognition / permission will operate for 2010-2011 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/affiliating body failing which the recognition will be effective from the

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Rudra Institute of Technology, Village – Mawana Khurd, Post – Mawana, Tehsil – Mawana, District – Meerut, Uttar Pradesh for 100 seats starting B.Ed Course of Secondary (Level) of one year duration from the academic session 2010-2011 under clause 7(11) of NCTE Regulations 2009.

- i) The admission of the students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- ii) Formal recognition / permission will operate for 2010-2011 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/affiliating body failing which the recognition will be effective from the
- iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.
- iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993
