WHEREAS Chandra Prabha Mahavidyalalya, VPO- Sarai Neem, Tehsil- Jalesar, District- Etah, U.P. had applied for grant of recognition for B.ED Course of One year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 31.10.2008.

- 2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 146<sup>th</sup> Meeting held on 05<sup>th</sup> to 07<sup>th</sup> August, 2009, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the committee decided to issue **Show Cause Notice** to the applicant institution on 12.08.2009.
- 4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 27.08.2009. The original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 148<sup>th</sup> Meeting held on 28<sup>th</sup> to 30<sup>th</sup> August 2009 the committee decides for re-inspection of the institution. Accordingly competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 5. AND WHEREAS in its 155<sup>th</sup> Meeting held on 23<sup>rd</sup> to 25<sup>th</sup> January, 2010, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution and decides to issue letter under clause 7(9) of Regulations 2007. Accordingly letter was issued to the applicant institution on 29.01.2010.
- 6. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 04.02.2010. The original file of the institution as well as other documents and materials submitted by the institution were again duly considered by the NRC in its **156**<sup>th</sup> Meeting held on **22**<sup>nd</sup> **to 23**<sup>rd</sup> **February 2010** and the committee decided to issued a show cause notice to the institution. Accordingly show cause notice was issued to the institution on 08.03.2010.
- 7. AND WHEREAS the applicant institution has submitted its representation to NRC, NCTE Jaipur on 22.03.2010. The matter was placed before the committee in its  $157^{th}$  Meeting held on  $24^{th}$  to  $27^{th}$  March, 2010, and decides:
  - The deficiency related to the teaching experience certificate of Dr. Ashutosh Pachori still remains.

The FDR of Rs. 5.00 Lakhs in original bearing no. 381850 & the FDR of Rs. 3.00 Lakhs in original bearing No. 381851 are returned herewith.
- 9. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
