WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Allahabad Agricultural Institute Deemed University, Allahabad, U.P., had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting M.Ed Course of One year duration with an annual intake of 25 (Twenty Five Only) students on 30.12.2002.

- AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 112<sup>th</sup> Meeting held on **27<sup>th</sup> to 28<sup>th</sup> December, 2006** the committee decided to issue Conditional Letter of Recognition to the institution and accordingly conditional recognition order was issued vide NCTE letter no. F.NRC/NCTE/F-7/10228 Dated 29.12.2006.
- AND WHEREAS a letter regarding issue of unconditional Recognition after receiving required documents in NRC NCTE within 21 days vide F.NRC/NCTE/F-7/UP-921/2007/20721 dated 03.07.2007 was issued to the institution. Reply from the institution was received on 14.03.2008.
- AND WHEREAS the matter was placed before the committee in its 141st Meeting held on 22<sup>nd</sup> to 24<sup>th</sup> May 2009, after perusal of original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time etc, decided to refuse recognition and return FDRs if submitted. Accordingly refusal order was issued to the institution on 17.07.2009 on the grounds that the list of appointed faculty as per NCTE norms has not been submitted till date".
- AND WHEREAS the institution preferred an appeal dated 10.08.2009 to the NCTE New Delhi, under section 18 of the NCTE Act 1993, against the said order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after hearing oral arguments advanced during the hearing the Council reached the conclusion that there was enough ground to accept the appeal and NRC's order dated 17.07.2009 was set aside with direction to the NRC to grant recognition to the institution immediately.
- AND WHEREAS a letter dated 08.10.2009 was issued to the institution regarding submission of list of appointed faculty as per NCTE Norms.
- AND WHEREAS the reply on 29.10.2009 received from the institution was placed before the committee in its 152<sup>nd</sup> Meeting held on 23td to 25<sup>th</sup> November 2009, the Committee observed some deficiencies and decided to allow the college to meet the deficiencies within 90 days.
- AND WHEREAS the reply received on 22.12.2009 from the institution placed before Committee in its 154<sup>th</sup> meeting held on 09<sup>th</sup> to 10<sup>th</sup> January 2010, and on careful perusal of original file of the institution, along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time etc, the committee directed the college to submit the required documents within 21 days. Accordingly a letter dated 19.01.2010 was issued to the institution.
