ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **Dayawanti Punj Training Institute**, **Vill & Post – Sitamarhi, Distt. – Sant Ravi Das Nagar (Bhadohi), Uttar Pradesh-221309** (UP-2109) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of one year duration with an annual intake of 100 (One Hundred) students on 22.04.2006.

AND WHEREAS the institution was inspected on 09.01.2007.

AND WHEREAS the original file of the institution, VTR, other related documents, VCD, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by NRC in its 114th meeting held on February 21-22, 2007. The Committee decided to grant recognition to the institution subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE /State Govt./ Affiliating University given effect before the commencement of the course. Accordingly, letter of conditional recognition was issued vide letter F.NRC/NCTE/F-7/2007/UP-2109/4448-50 dated 23.02.2007. In response, the institution submitted reply dated 20.07.2007 & 26.09.2007.

AND WHEREAS the matter was placed before the 141st Meeting of NRC held on 22-24 May, 2009 and the Committee decided to refuse recognition and return FDRs, if submitted. Accordingly, order of refusal of recognition was issued to the institution vide order No.NRC/NCTE/F-7/UP-2109/2009/10743-10749 dated 26.09.2009 on the following grounds:

 The list of appointed Faculty as per NCTE Norms has not been submitted till date.

AND WHEREAS the institution preferred an appeal dated 30.10.2009 to the NCTE, New Dolhi under Section 18 of the NCTE Act, 1993 against the said order. The Council after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, came to the conclusion that there was adequate ground to accept the appeal, set aside NRC's order dated 26.09.2009 and remand the case to NRC vide order F.No.89-1298/2009-Appeal/ dated 05-01-2009 with the direction to give some more time to the institution to comply with the condition laid down in the conditional recognition order, in view of the court directions given to the affiliating body.

AND WHEREAS, the matter was again placed before the NRC, NCTE in its 155th meeting hold on January 23-25, 2010 and the committee decided to issue a letter directing to submit a fresh list of appointed faculty as per NCTE norms within three months. Accordingly, letter issued vide F.No.NRC/NCTE/UP-2109/Appeal/155 Meeting/5832 dated 01.02.2010.

AND WHEREAS, the reply submitted by the institution was placed before the NRC, NCTE in its 158th meeting held on April 19-22, 2010 and the committee decided to issue a letter to the institution seeking clarification. Accordingly, clarification sought from the institution vide letter No.NRC/NCTE/UP-2109/158 Meeting/2010/21775 dated 11.05.2010 on the following points:

The two appointed teachers, namely, Dr. (Mrs.) Kiran Mishra and Mrs. Susham Pandey are not qualified as per NCTE norms for B.Ed. course.

AND WHEREAS, the reply submitted by the institution was placed before the NRC, NCTE in its 160^{th} meeting held on May 18-20, 2010 and the committee decided to issue a show cause notice to the institution. Accordingly, show cause notice issued vide letter No.NRC/NCTE/UP-2109/160 Meeting/2010/22978 dated 02.06.2010 on the following points:-

The faculty has not been appointed on full time and regular basis.

AND WHEREAS, the reply submitted by the institution was placed before the NRC, NCTE in its Emergency Meeting held on July 19, 2010 and the committee decided to issue letter under Clause 7(11) of Regulations 2007.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Dayawanti Punj Training Institute, Vill & Post — Sitamarhi, Distt. — Sant Ravi Das Nagar (Bhadohi), Uttar Pradesh-221309 for conducting B.Ed Course of Secondary (Level) of one year duration with an annual intake of 100 (One Hundred) Students under clause 7(11) of NCTE Regulations, 2007. The decision of the Council would, however, be operative from the date of withdrawal of the ban on further recognition of B.Ed course in the State of Uttar Pradesh.

- (i) Order for recognition will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.
- (ii) The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
