WHEREAS, in terms of section 15(1) of the NCTE Act, 1993 Regency Teachers Training College, Ramkot Road, VPO- Raseora, Tehsil- Sitapur, District- Sitapur-261001, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting M.Ed. Course of One year duration with an annual intake of 35 (Thirty Five Only) students on 22.09.2008.

AND WHEREAS, the Inspection of the said institution under section 15 was conducted by visiting team on **11.06.2009**.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Northern Regional Committee in its 145th Meeting held on 26th to 28th July, 2009 decided to issue a Show Cause Notice on certain points. Accordingly a Show Cause Notice issued to the institution on 14.08.2009 & reply of the same was received on 03.09.2009.

AND WHEREAS, the matter was placed before NRC in its 149th Meeting held on 13th to 14th September, 2009 & it was decided to send VT to verify the facts.

AND WHEREAS, the re-inspection of the said institution under section 15 was conducted by visiting team on 23.11.2009.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Northern Regional Committee in its-154th Meeting held on 09th to 11th January, 2010 decided to issue letter under clause 7(9) of Regulations 2007 & accordingly, letter of Intent prior to recognition was issued on 19.01.2010.

AND WHEREAS, the applicant institution has not submitted any representation, the matter was placed before NRC in its 157th Meeting held on 24-27.03.2010, and the Committee decided to close the file. Accordingly, order was issued on 15.04.2010.

AND WHEREAS, the above said Institution, thereafter preferred an appeal dated US.05.2010 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order.

AND WHEREAS, after perusal of documents, Memorandum of appeal, affidavit and VT Report, and considering oral arguments advanced during the hearing, the Council came to the conclusion that there is adequate ground to accept the appeal and set-aside NRC's order dated 15.04.2010 and remand back the case to NRC vide order dated 19.07.2010 for examination of the faculty profile and for further decision thereafter and the institution was directed to send a set of documents of the faculty selection and appointment to the NRC immediately. The applicant institution submitted its reply vide letter dated 06.08.2010.

AND WHEREAS, the matter was placed before NRC in its **164**th **Meeting held on 28**th **to 29**th **August, 2010**, the Committee decided to issue letter under clause 7(11) of Regulations 2009.

AND WHEREAS, the NCTE has issued letter No.48-6/PT-III/ NCTE (N&S) dated 31.08.2010 in which it was stated that the matter regarding issue of recognition order under clause 7(9) or 7(11) of NCTE Regulations to the institution which were found eligible for grant of recognition order on merit but where order could not be issued due to the ban imposed by the NCTE on 26^{th} July, 2009 has been considered by the Council and it is clarified that such pending orders now be issued. This is due to the consideration that the present ban is only on fresh receipt of application for the academic session **2011-2012** and therefore the old pending cases are to be disposed on merit without any reference to the ban.

AND WHEREAS, the above letter of NCTE, Headquarter was considered by NRC in its **166**th **Meeting held on 9**th **September, 2010** and NRC decided that the recognition order under section 7 (11) of NCTE, Regulations in all such pending cases where NRC or Council (NCTE) had decided to grant recognition under section 7 (11) of NCTE Regulations be issued from the session 2010-2011 subject to the following condition:-

- The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- ii) Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Regency Teachers Training College, Ramkot Road, VPO- Raseora, Tehsil- Sitapur, District-Sitapur-261001, Uttar Pradesh for conducting M.Ed Course of PG (Level) of one year duration with an annual intake of 35 (Thirty Five Only) students from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions:-

- (i) The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- (ii) Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The Institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- · Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
