WHEREAS Aster College Of Education, J-1, Sector -9, Delta - II, Greater Noida, Distt. -G.B. Nagar, U.P. was granted recognition for running B.Ed Course of One year duration with an annual intake of 100 (One hundred Only) students vide this office order no. F. NRC/NCTE/F-3/UP-1064/2003/8187-8195 dated 24.01.2004.

AND WHEREAS the recognition of the Institution was withdrawn vide this office order no. F. NRC/NCTE/F-3/UP-1064/2009/11986-11992 dated 04.11.2009.

AND WHEREAS the Institution preferred an appeal to the Appellate Authority against the NRC order dated 04.11.2009 and the council after perusal of documents, memorandum of appeal, VT report, affidavit and order considering oral arguments advance during hearing, the council reached the conclusion that there was enough ground to accept the appeal. The Council decided to the NRC for issuing a revised speaking order by restoring recognition for basic unit of B.Ed. Course only, but the recognition for the additional unit of B.Ed. course shall be withdrawn Accordingly, the case was remanded to the NRC.

AND WHEREAS the Institution has submitted the judgment passed by the Hon'ble High Court of Allahabad in the matter of Writ Petition No. C.NO.38946 of 2010. In view of the matter the order dated 01.06.2010 passed by the applicant Authority is modified to the extent the not only the recognition for the basic unit of 100 seats shall be restored but the recognition for the Additional 100 seats shall also be restored.

AND THEREFORE the matter was considered in 163th Meeting of NRC held from 29th to 31 July, 2010 & the Committee decided to implement the order of Hon'ble High Court of
