ORDER

WHEREAS in terms of section 14(1) of the NCTE Act, 1993 Shukdeo Prasad Tripathi Mahavidyalaya, VPO-Bhathahin Khurd, (Shukdec Nagar) Via- Fazilnagar, Distt.- Khushi Nagar, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for additional 100 seats B.Ed Course of one year duration with an annual intake of 100 (One hundred Only) students on 21.02.2007.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography the input received from, recommendation of the State Government. The Northern Regional Committee in its 121st Meeting held from September 07th and 09th 2009, decided to 7(11) with separate letter for painting of walls, providing pf black boards. Accordingly a letter of intent was issued to the institution on 15.09.2009.

AND WHEREAS, the matter was placed before NRC in its 141st Meeting held from 22nd May to 24th May, 2009 & The Committee decided to refuse recognition close the file and return the FDRs. Accordingly refusal order was issued on 17.07.2009.

AND WHEREAS the above said Institution, thereafter preferred an appeal before the Council under section 18 of the NCTE Act, 1993 against the aforesaid order of NRC and the case was remanded back to NRC by the Council vide order dated 07.8.2009 with direction to NRC to cause was remanded back to the NRC for reconsideration and there after issue of appropriate order.

AND WHEREAS, the matter was placed before NRC in its 148th Meeting held from 28th and 30th August, 2009 & The Committee decided to seek clarification from Hq whether order is to be issued for B.Ed. course or B.Ed. Additional intake. Accordingly a letter was issued on 09.09.2009.

AND WHEREAS, the matter was placed before NRC in its 153rd Meeting held from 11th and 12th December, 2009 & The Committee decided to show cause on certain points. Accordingly a Show Cause Notice was issued to the institution on 17.12.2010. & reply of the same was received on 15.01.2010.

AND WHEREAS, the matter was placed before NRC in its 155rd Meeting held from 23rd and 25th January, 2010 & The Committee decided to refuse recognition for B.Ed. additional seats and return FDRs. Accordingly a refusal order was issued to the institution on 29.01.2010. The institution had filed an civil misc, writ petition No. 51245 of 2009 against the order of NRC. The Court had passed order dated 06/10/2009 with direction to NRC to pass appropriate orders on the pending matter relating of approval of 100 additional seats in B.Ed. accordance with the law within three month.. The matter was considered by the NRC in its 156th meeting and as per the decision of NRC, the show cause notice was issued to the institution on 16/03/2010. The matter was again considered by NRC its 162<sup>nd</sup> meeting and as per the decision, the recognition was refused vide order dated 16/07/2010. Thereafter, the institution had preferred an appeal under section 18 of NCTE, Act, 1993 before the Council against the order of NRC. The Council had passed order dated 28/09/2010 in the appeal filed by the institution with direction to NRC to issue formal order of recognition within 15 days of issue of the appellate order.

NOW, THEREFORE, In compliance of order dated 28/09/2010 passed by the Council and in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Shukdeo Prasad Tripathi Mahavidyalaya, VPO-Bhathahin Khurd, (Shukdeo Nagar) Via- Fazilnagar, Distt.- Khushi Nagar, Uttar Pradesh for 100 additional seats in B.Ed Course of Secondary (Level) of one year from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions. The total seats will be 200 (100 existing + 100 additional).

- The admission of the students against the additional seats shall be completed well before the cut off date prescribed by the examining body for admission to the academic session 2010-2011 failing which admission for additional seats shall be given from the academic session 2011-2012.
- ii) Formal recognition / permission for additional seats will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/affiliating body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and iii) reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

V) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.
