

WHEREAS in terms of Section 14(1) of the NCTE Act, Lal Bahadur Shashtri Post Graduate College, Anand Nagar, Distt. - Maharajganj - 273155, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting **B.Ed.** Course of **One year** duration with an annual intake of 100 (One Hundred Only) students on 04.12.2006

- AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 117th Meeting held on 26th to 28th May, 2007, the committee decided to Issue Letter of Intent Prior to Recognition. Accordingly Letter of Intent Prior to Recognition order was issued vide NCTE letter no. F.NRC/NCTE/F-3/UP-2237/18784-87 Dated 11.06.2007.
- AND WHEREAS the applicant institution did not make reply to this office order dt. 11.06.2007. A letter for compliance to this office order dt. 11.06.2007 was issued to the institution on 30.06.2007. The institution did not make its representation to Northern Regional Committee. The matter was placed before NRC in its 141st Meeting held on 22<sup>nd</sup> to 24<sup>th</sup> May, 2009 and the committee decided to refuse the recognition for B.Ed. Course of One year duration. Accordingly order was issued vide order no. F.NO. NRC/NCTE/F73/UP-2237/141 Meeting/2009/9583-6589 dated 22.07.2009. The above said institution, thereafter preferred an appeal dated 14.07.2009 to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order.
- 4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal, and set-aside NRC's order dated 22.07.2009 and remand back the case to NRC for examination of the staff profile and thereafter pass appropriate order.
- 5. AND WHEREAS the matter was again placed before the NRC NCTE in its 153<sup>rd</sup> Meeting held on 11<sup>th</sup> to 12<sup>th</sup> December, 2009 and the committee decided to reiterates the decision of NRC taken in its 141<sup>st</sup> Meeting. The above said institution, thereafter preferred an appeal dated 12.01.20109 to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order again.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal, and NRC's order dated  $11^{th}$  –  $12^{th}$  December, 09 was reversed with a direction to the NRC to grant formal recognition order in continuation of conditional recognition order within 15 days of issue of this order in its order no. F.No. 89-26/2010 APPEAL dated 05.03.2010.
- AND WHEREAS the matter was again placed before the NRC NCTE in its 157th Meeting held on 24th to 27th March, 2010 and the committee decided to process the file as per the decision of the appeal committee.
- NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Lal Bahadur Shashtri Post Graduate College, Anand Nagar, Distt. - Maharajganj - 273155, Uttar Pradesh for conducting B.Ed., Course of Secondary (Level) of One year duration with an annual intake of 100 Students (One Hundred only) students in continuation to the conditional recognition order No. F.NRC/NOTE/F-3/UP-2237/18787-87 dt. 11.06.2007 under clause 7(11) of NCTE Regulation, 2007.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional
- The institution shall comply with the various other norms and standards prescribed in the NCTE 10. regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc,
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. In respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
  - Copy of the Application Form
  - Land and Building Particulars
  - Staff Profile
  - Recognition letter
  - Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name 16. of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
