WH_RE/S in terms of section 14(1) of the NCTE Act, 1993 Rakshpal Bahadur Teachers Training Institute, Plot No. 119, Village – Barinagla, Post Office – Umarsiya, Tehsil – Bareilly, District – Bareilly – 243001, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of permission for additional 100 seats in B.Ed. Course of One year duration on 08/07/2008

AND WHEREAS, the Inspection of said Institution was conducted on 03.03.2009.

AND WHEREAS, on scrutiny perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography the input received from, recommendation of the State Government. The Northern Regional Committee in its 149th Meeting held from 13th to 14th September, 2009 decided to issue Show Cause Notice on certain deficiencies. Accordingly show cause notice was issued to the institution on 25/09/2009.

AND WHEREAS, the matter was again considered by NRC in its 151st Meeting and as per the decision of NRC letter of intent prior to grant of recognition in respect of institution under section 7(9) of the NCTE Regulations was issued on 04.12.2009.

A. D WHEREAS, the matter was again considered by NRC in its 158th meeting and as per the decision of NRC, recognition was again refused vide order dated 14/05/2010. The institution had filed an appeal before the Council under section 18 of NCTE, Act, 1993 against the order of NRC, the order of NRC's was set aside by the Council vide order dated 27/08/2010 and remand back the case to NRC for examining the staff profile submitted by the institution and passing appropriate order thereafter. Accordingly, the appeal was accepted, the order of the NRC dated 1.05.2010 set-aside and the case remanded back to NRC for examination of the staff profile submitted by the institution on 19.04.2010 and passing appropriate order thereafter as per the regulations,

AND WHEREAS, the reply of the institution received in the office of NRC on 15/09/2010 w.r.t. letter of intent prior to recognition under section 7(9) of the NCTE Regulation, 2009 has been carefully considered by NRC in its 171st Meeting held from 28th and 29th October, 2010 and committee decided that recognition for additional 100 seats in B.Ed. Course under clause 7(11) of NCTE Regulation, 2009 be granted to the Institution subject to the following conditions:-

- The admission of students against additional seats shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- ii) Formal orders for recognition/permission of additional seats will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Rakshpal Bahadur Teachers Training Institute, Plot No. 119, Village – Barinagla, Post Office – Umarsiya, Tehsil – Bareilly, District – Bareilly – 243001, Uttar Pradesh for additional 100 seats in B.Ed. one year Course from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions:

The admission of the students against additional seats shall be completed well before the cut off date prescribed by the examining body for admission to the academic session 2010-2011 failing which admission for additional seats shall be given from the academic session 2011-2012.

Formal recognition / permission of additional seats will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/affiliating body failing which the recognition will be additional 10 seats an effective from the academic session 2011-2012.

- iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.
- iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect on the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
