WHEREAS in terms of section 15(1) of the NCTE Act, 1993 Raj Narayan Pandey Degree College, Plot/Khasra No. -23020188133/00379, Village - Berui, Post - Garapur, Tehsil - Phoolpur, District- Allahabad-221507, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.P.Ed Course of one year duration with an annual intake of 50 (Fifty Only) students on 30.10.2008.

AND WHEREAS, the matter was placed before NRC in its 140th Meeting held on 25th and 26th April, 2009 & the Committee decided that the LOI for inspection be issued subject to submission of resolution of gram panchayat for approval of building plan Accordingly letter was issued on 17.05.2009. & reply of the same was received on 12.06.2009. As per decision of NRC, Inspection was conducted.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography the input received from, recommendation of the State Government. The Northern Regional Committee in its 148th Meeting held on 28th to 30th August, 2010 decided to issue Show Cause Notice on certain points. Accordingly a Show Cause Notice was issued to the institution on 31.08.2009. & reply of the same was received on 07.10.2009.

AND WHEREAS, the reply of the Institution was placed before NRC in its 151st Meeting held on October, 20th to 21st, 2010 & as per decision of NRC, VT was sent on 4.3.2010 to verify the facts of removal of deficiencies.

AND WHEREAS, The VTR was considered by NRC in its 159th Meeting held from 28th April to 01st May, 2010 and the committee decided that letter under clause 7(9) of regulations 2009 be issued to the Institution. Accordingly a letter under clause 7(9) was issued to the institution on 11.05.2010. & reply of same was received on 21.05.2009.

AND WHEREAS, the reply of the Institution was placed before NRC in its 161st Meeting held from May, 26th to 29th, 2010 & Committee decided that the recognition for B.ED. course under clause 7(11) of NCTE, Regulation, 2007 be granted subject to development of college website as per the NCTE, Regulations. As per the decision of NRC letter dated 10/06/2010 was issued to the institution and the reply of the same was considered by NRC in its 168th meeting and NRC decided that the recognition for B.P. Ed, course under clause 7 (11) of NCTE, Regulations, 2009 be granted to the institution subject to the following condition:

- The admission of students shall be made only after affiliation by the examining body before the i) commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching ii) in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Raj Narayan Pandey Degree College, Plot/Khasra No. -23020188133/00379, Village -Berui, Post - Garapur, Tehsil - Phoolpur, District- Allahabad-221507, Uttar Pradesh for conducting B.P.Ed Course of Secondary (Level) of one year duration with an annual intake of 50 (fifty Only) students from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions:

- The admission of students shall be made only after affiliation by the examing body before the commencement of the academic session land the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching ii) days n the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and iv) reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six months in the name of the institution failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993
