#### **ORDER**

WHEREAS in terms of section 14(1) of the NCTE Act, 1993 Maa Babuna Balika Mahavidyalaya, Khasra No. 1143, VPO-Bargahan, Tehsil, Lalganj, District- Azamgarh, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of one year duration with an arnual intake of 100 (One hundred Only) students on 27.10.2008.

AND WHEREAS, the matter was placed before NRC in its 139<sup>th</sup> Meeting held on from 10<sup>th</sup> April to 12<sup>th</sup> April, 2009 & The Committee decided to close the file and return the FDRs. Accordingly order was issued on 28.05.2009.

AND WHEREAS the above said Institution, thereafter preferred an appeal dated 18.08.2009 before the Council under section 18 of the NCTE Act, 1993 against the aforesaid order of NRC and the case was remand back to NRC by the Council vide order dated 05.01.2010 with direction to NRC to cause Inspection of the Institution. As per direction of the Council, Inspection was conducted on 17.06.2010

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography the input received from, recommendation of the State Government. The Northern Regional Committee in its 163<sup>rd</sup> Meeting held on 29<sup>th</sup> to 31<sup>st</sup> July,2010 decided to issue Show Cause Notice on certain points. Accordingly a Show Cause Notice was issued to the institution on 14.07.2010.

AND WHEREAS the reply of the Institution was placed before NRC in its 167<sup>th</sup> Meeting held on from September, 28-30, 2010 & Committee decided that the recognition for B.ED. course under clause 7(11) of NCTE Regulation, 2009 be granted to the Institution subject to the following condition:-

- i) The admission of students shall be made only after affiliation by the examing body before the commencement of the academic session land the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Maa Babuna Balika Mahavidyalaya, Khasra No. 1143, VPO-Bargahan, Tehsil, Lalganj, District- Azamgarh, Uttar Pradesh for conducting B.Ed Course of Secondary (Level) of one year duration with an annual intake of 100 (One hundred Only) students from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions:

- The admission of students shall be made only after affiliation by the examing body before the commencement of the academic session land the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

- The institution shall comply with the various other norms and standards prescribed in the NCTE iv) regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms V) of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993
