ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 D.I.E.T. Rewari-123401 (HR-201) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting D.ED. Course of two year duration with an annual intake of 50 (Fifty Only) students on 31.12.03.

2. AND WHEREAS, the application was processed and inspection conducted on 07.08.04 was placed in 82nd Northern Regional Committee meeting held from 26th to 27th August, 2004 and the Northern Regional Committee decided that the institution may be given an opportunity to make written representation to NRC before refusing recognition of D.ED. course on account of certain deficiencies. Accordingly the letter was issued on 31.08.04.

3. AND WHEREAS, the matter considered in 84th Northern Regional Committee meeting held from 05th to 06th October, 2010 and the Committee noted that affidavit has not been submitted by the institution in support of documentary proof. Hence NRC decided that affidavit be obtained from the institution. Accordingly a letter was issued on 12.10.04.

4. AND WHEREAS, the reply of the institution was considered in 86th Northern Regional Committee held from 16th to 17th December 2004 and the Regional Committee decided that Second Inspection of the institution be conducted to verify the facts claimed by the institution in its written representation.

5. AND WHEREAS, the inspection U/s 15 of the institution conducted on 28.04.05 was placed in 92nd Northern Regional Committee held on 01st June, 2005 and Committee decided that the institution may submit documentary proof duly certified by the competent authority w.r.t. each deficiency notified as above along with an Affidavit supporting the above points. Accordingly letter was issued on 17.06.05.

6. AND WHEREAS, the reply of the institution was placed in 94th Northern Regional Committee Meeting held from 21st to 23rd July, 2005 and the Committee decided that the institution be asked to confirm the completion of the construction work and creation of infrastructural and instructional facilities as pointed out in the Show Cause Notice. Accordingly letter was issued on 09.08.05.

7. AND WHEREAS, the reply of the institution was placed in 97th Northern Regional Committee Meeting held from 27th to 28th October, 2005 and the Committee directed the office to send letters to the concerned official by name bringing to their notice that the above four DIETs are functioning without the formal recognition of NCTE. Accordingly letter to Director SCERT, Gurgaon was issued on 13.12.05.

8. AND WHEREAS, the reply of the institution was placed in 159th Northern Regional Committee meeting held from 28th April to 01st May, 2010 and the Committee decided to issue Show Cause Notice on certain points and directs the Institute to submit reply within 30 days. Committee also decided that VT may be sent.

9. AND WHEREAS, the reply of the institution was placed in 160th Northern Regional Committee meeting held from 18th to 20th May, 2010 and the Committee decided to issue Show Cause Notice on certain points and ask the State Government to reply within 30 days. Accordingly a Show Cause Notice was issued on 10.06.2010.

10. AND WHEREAS, the reply, inspection conducted on 09.09.10, VT report were considered in 167th Northern Regional Committee meeting held from 28th to 30th September, 2010 and Committee decided, that a Show Cause Notice u/s 14 (3) (b) of NCTE, Act, 1993 be issued to the institution before refusing the recognition of proposed D.Ed. course on certain grounds. Accordingly Show Cause Notice U/s 14(3)(b) was issued on 21.10.10.

11. AND WHEREAS, the reply of the institution was placed in 173rd Northern Regional Committee meeting held from 24th to 26th November, 2010 and the Committee decided that recognition order under clause 7(11) of NCTE regulations 2009 in terms of section 14(3)(a) of NCTE Act, 1993 for D.Ed. Course with an annual intake of 50 seats from the academic session 2010-11 be issued.

12. NOW THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to **D.I.E.T. Rewari-123401 (HR-201)** for **D.Ed. Course** of two year duration with an annual intake of **50 (Fifty only) Students** under **clause 7(11)** of NCTE Regulations from the **academic session 2010-2011** subject to the following conditions:-

1. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
2. Formal order for recognition/permission will operate for 2010-2011 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
3. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund in the joint name of an authorized representative of the management and the Regional Director, Northern Regional Committee.
4. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
5. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations.

13. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

14. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

15. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

16. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

10. Copy of the Application Form
11. Land and Building Particulars
12. Staff Profile
13. Recognition letter
14. Information for having fulfilled the norms & standard and other required conditions.

17. In case if the land is in the name of the Society, the institution must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
