

WHEREAS in terms of Section 14(1) of the NCTE Act, Shri Shankar Ji Mahavidyalaya, Mathiya, Ambedkar Nagar, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition for starting B.Ed. Course of One year duration with an annual intake of 100 (One Hundred Only) students on 27.12.2004

- 2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 109<sup>th</sup> Meeting held on 31<sup>st</sup> October to 01<sup>st</sup> November, 2006, the committee decided to issue conditional recognition. Accordingly conditional recognition order was issued vide NCTE letter no. F.NRC/NCTE/F-3/UP-1687/2006/7726-7735 Dated 07.11.2006.
- 3. AND WHEREAS the applicant institution did not make reply to this office order dt. 07.11.2006. A letter for compliance to this office order dt. 07.11.2006 was issued to the institution on 03.07.2007. The institution made its representation to Northern Regional Committee on 30.07.2007. After consideration of the reply submitted by the institution, a letter was again issued to the institution for submission of the staff profile as pr the NCTE norms on 06.02.2008. The institution did not make its representation and the matter was placed before NRC in its 141<sup>st</sup> Meeting held on 22<sup>nd</sup> to 24<sup>th</sup> May, 2009 and the committee decided to refuse the recognition for B.Ed. Course of One year duration. Accordingly order was issued vide order no. F.NO. NRC/NCTE/F73/UP-1687/141 Meeting/2009/6887-689 dated 24.07.2009. The above said institution, thereafter preferred an appeal dated 14.10.2009 to the NCTE, New Delhi. Under section 18 of the NCTE Act
- 4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal and reverses NRC's order dated 24.07.2009 with a direction to the NRC for issuing formal recognition order in continuation of conditional recognition gratned vide order dated 07.11.2006 in its order no. F.NO. 89-1230/2009 APPEAL dated 12.02.2010.
- 5. AND WHEREAS the matter was again placed before the NRC NCTE in its 157<sup>th</sup> Meeting held on 24<sup>th</sup> to 27<sup>th</sup> March, 2010 and the committee decided to process the file as per the decision of the appeal
- 6. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Shri Shankar Ji Mahavidyalaya, Mathiya, Ambedkar Nagar, Uttar Pradesh for conducting B.Ed.. Course of Secondary (Level) of One year duration with an annual intake of 100 Students (One Hundred only) students in continuation to the conditional recognition order dt. 07.11.2006 under clause 7(11) of NCTE Regulation, 2007
- 7. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- 8. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 9. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. - If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, 12. Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
  - Copy of the Application Form
  - Land and Building Particulars
  - Staff Profile
  - Recognition letter
  - Information for having fulfilled the norms & standard and other required conditions.
- In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
