WHEREAS in terms of Section 14(1) of the NCTE Act, Shaheed Mangal Pandey Govt. Girls 2010 Degree College, Madhav Puram, Distt. - Meerut, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition for starting B.Ed. Course of One year duration with an annual intake of 100 (One Hundred Only) students on 12.04.2005

- 2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 109th (IInd Sitting) & 110th Meeting held on 10th November, 2006, the committee decided to issue conditional recognition. Accordingly conditional recognition order was issued vide NCTE letter no. F.NRC/NCTE/F-7/8314-8339 & 8371 8379 Dated 14.11.2006.
- 3. AND WHEREAS the applicant institution did not make reply to this office order dt. 07.11.2006. A letter for compliance to this office order dt. 14.11.2006 was issued to the institution on 09.07.2007. The institution did not make its representation and the matter was placed before NRC in its 141st Meeting held on 22nd to 24th May, 2009 and the committee decided to refuse the recognition for B.Ed. Course of One year duration. Accordingly order was issued vide order no. F.NO. NRC/NCTE/F73/UP-1991/141 Meeting/2009/10841-10847 dated 26.09.2009. The above said institution, thereafter preferred an appeal dated 23.10.2009 to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order.
- 4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal and reverses the order of NRC dated 26.09.2009 with a direction to the NRC for issuance of formal recognition order in continuation of conditional recognition order, so that the recognition of the institution gets effective from the year if affiliation by the University after issue of conditional recognition order.
- 5. AND WHEREAS the matter was again placed before the NRC NCTE in its 157th Meeting held on 24th to 27th March, 2010 and the committee decided to process the file as per the decision of the appeal committee.
- 6. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Shaheed Mangal Pandey Govt. Girls Degree College, Madhav Puram, Distt. Meerut, Uttar Pradesh for conducting B.Ed. Course of Secondary (Level) of One year duration with an annual intake of 100 Students (One Hundred only) students in continuation to the conditional recognition order dt. 14.11.2006 under clause 7(11) of NCTE Regulation, 2007
- 7. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 9. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

A copy of the format is enclosed with the order.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Information for having fulfilled the norms & standard and other required conditions. Recognition letter
- In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
