WHEREAS in terms of section 14(1) of the NCTE Act, 1993 Ramjag Mahavidyalaya, Vill-Mardanpur, Plot No. - 570, 557 & 23, I st. Rampur Balbhadra, Tehsil- Jakhania, District- Ghazipur. Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of one year duration with an annual intake of 100 (One hundred Only) students on 29.10.2008.

ANT WITEREAS, the Inspection of said Institution was conducted on 06.09.2009.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography the input received from, recommendation of the State Government. The Northern Regional Committee in its 150 Meeting held from 09th to 11th October, 2009 decided to issue Show Cause Notice on certain points. Accordingly a Show Cause Notice was issued to the institution on 29.10.2010. & reply of the same was received on 11.11.2009.

AND WHEREAS, the matter was placed before NRC in its 154th Meeting held from 09th and 11th January, 2010 & as per the decision of NRC Inspection of said was again conducted on 24.03.2009.

AND WHEREAS, the matter was placed before NRC in its 159th Meeting held from 28th April to 01st May, 2010 & The Committee decided that letter under clause 7(9) of regulations 2007 be issued to the Institution. Accordingly a letter under clause 7(9) was issued to the institution on 15.05.2010. & rep¹ of same was received on 10.06.2010 & 18.06.2010.

AND WHEREAS, the reply of the Institution was placed before NRC in its 162nd Meeting held on from 24th and 27th June, 2010 & the Committee decided that the recognition for B.ED. Course under clause 7(11) of NCTE Regulation, 2007 be granted to the Institution.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Ramjag Mahavidyalaya, Vill- Mardanpur, Plot No. – 570, 557 & 23, Post- Rampur Balbhadra, Tehsil- Jakhania, District- Ghazipur. Uttar Pradesh for conducting B.Ed Course of Secondary (Level) of one year duration with an annual intake of 100 (One hundred Only) students from the academic session 2010-2011 under clause 7(11) of NCTE Regulations subject to the following conditions as per decision taken in 166th meeting.

- i) The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
- Formal orders for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fluifilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee
- iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- V) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
