ORDER

WHEREAS Indira Gandhi Girls Degree College, Rampur, Taramandal, District-Gorakhpur, Uttar Pradesh had applied for grant of recognition for B.P.Ed Course of one year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 30.04.2007.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- AND WHEREAS the Northern Regional Committee after considering the report of the 3. visiting team as well as other relevant materials furnished by the applicant institution and the committee decided to issue a Show Cause Notice to the institution. Accordingly show cause notice was issued to the institution on 23.01.2009.
- AND WHEREAS the applicant institution has submitted its representation to the NRC NCTE on 20.04.2009. The matter was considered by the committee in its 139 Meeting and decides to issue Letter of Intent Prior to Recognition. Accordingly letter was issued to the institution on 19.05.2009. The applicant institution has not submitted the representation to the NRC NCTE. The Matter was considered by the committee in its 145 Meeting and decided to refuse the recognition for B.P.Ed Course. Accordingly order of refusal was issued to the institution on 26.09.2009.
- AND WHEREAS the above said institution preferred an appeal dated 20.10.2009 to the NCTE, New Delhi Under section 18 of the NCTE Act 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after hearing oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal, set aside NRC's order dated 26.09.2009 and remanded the case to the NRC for issuing Letter of intent prior to grant of recognition under clause 7(9) of the NCTE Regulation. Accordingly letter of intent prior to recognition was issued to the institution on 18.02.2010
- AND WHEREAS the applicant institution has not submitted its representation to the NRC NCTE Jaipur. The matter was placed before the committee in its 158th Meeting held on 19th to 22nd April, 2010 and the committee observes:
 - The Institution was issued 7(9) which has not been replied till date.
- AND WHEREAS the committee decides to close the file. 8.
- NOW THEREFORE grant of recognition to Indira Gandhi Girls Degree College, Rampur, Taramandal, District- Gorakhpur, Uttar Pradesh for the course in B.P.Ed in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
