Accordingly competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 154th Meeting held on 09th to 11th, January 2010, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution and decides to issue letter under clause 7(9) of Regulations 2007. Accordingly letter was issued to the applicant institution on 18.01.2010.
- AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The matter was placed before the committee in its 157th Meeting held on 24th to 27th March, 2010, and observes:

- AND WHEREAS the committee decided to close the file. 7.
- NOW THEREFORE grant of permission to Krishna Pal Singh Degree College, VPO-Tambour, Tehsil- Laharpur, District- Sitapur, U.P. for the course in M.ED in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
