ORDER

WHEREAS Ranjit Singh Memorial Post Graduate College, Vill- Rampur Bhola, Post- Dhampur, Tehsil- Dhampur, District- Bijnor, U.P. had applied for grant of recognition for B.ED Course of One year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 29.07.2008.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 144th Meeting held on 12th to 14th July, 2009, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the committee decided to issue Show Cause Notice to the applicant institution on 21.07.2009.
- ANDWHEREAS the applicant institution has submitted the representation to the NRC NCTE on 07.08.2009. The original file of the institution, reply of the institution under section 14 along with all other related documents, Act of NCTE, 1993 and the committee decided to refuse recognition for B.Ed course, Accordingly refusal order was issued to the institution on 09.09.2009. The above said institution, thereafter preferred an appeal dated 18.09.2009 to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after considering oral arguments advanced during the hearing, the council reached the conclusion that there was adequate ground to accept the appeal, and NRC's order dated 09.09.2009 and remand back the case to NRC to issue letter of intent prior to recognition under clause 7(9) of the NCTE Regulation. Accordingly letter was issued to the institution on 06.01.2010.
- AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 04.02.2010. The matter was placed before the committee in its 157th Meeting held on 24th to 27th March, 2010, and observes:
 - The Institution has not replied letter F.NO./ NRC/ NCTE/ UP-3063/ Appeal/ 2010/ 14513-514 dated 06 January 2010.
- 7. AND WHEREAS the committee decides to close the file.
- NOW THEREFORE grant of permission to Ranjit Singh Memorial Post Graduate College, Vill- Rampur Bhola, Post- Dhampur, Tehsil- Dhampur, District- Bijnor, U.P. for the course in **B.ED** in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
