- 2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- 3. AND WHEREAS in its 147th Meeting held on 16th to 17th August, 2009 the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the committee decided to issue **Show Cause Notice** to the applicant institution on 20.08.2009.
- 4. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 10.09.2009. The original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 149th Meeting held on 13th to 14th September 2009 the committee decides for re-inspection of the institution. Accordingly competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.

AND WHEREAS in its **155**th Meeting held on **23**rd **to 25**th **January, 2010**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution and decides to issue letter under clause 7(9) of Regulations 2007. Accordingly letter was issued to the applicant institution on **01.02.2010**.
- 6. AND WHEREAS the applicant institution has not submitted representation to Northern Regional Committee, NCTE. The matter was placed before the committee in its **157**th Meeting held on 24th to 27th March, 2010, and observes:
 - The Institution was issued 7(9) which has not been replied till date.
- 7. AND WHEREAS the committee decided to close the file.
- 8. NOW THEREFORE grant of recognition to Matri Gangajali Degree College, VPO-Maudhian, Tehsil- Jakmanian, District- Ghazipur, U.P. for the course in B.ED in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused.
