- AND WHEREAS Hence, the committee decides to refuse recognition and return FDR's if submitted.
- NOW THEREFORE grant of recognition to **DISTRICT INSTITUTE OF EDUCATION &** TRAINING, RAH-E-RAZA, RAMPUR-244901, U.P. for the course in BTC Additions **Intake** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
