ORDER

WHEREAS **DISTRICT INSTITUTE OF EDUCATION & TRAINING, RAH-E-RAZA, , , RAMPUR-244901, U.P.** of recognition (**UP-1020**) for **BTC Additional Intake** of Two years (2) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **30.09.2003**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS in its 104th Meeting held on **15th to 17th July 2006**, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution, was satisfied and the committee decided to issue letter of conditional Recognition to the applicant institution on **09.09.2006**. Accordingly the conditional recognition letter was issued by this office letter no. F.NO.NRC/NCTE/F-7/UP-1020/2006/3522-24 dated 07.08.2006 with a direction to the institution to:-

- **Appoint duly selected staff with the requisite qualification as per NCTE Norms and Standards and inform the Regional committee.**

4. AND WHEREAS the applicant institution did not comply with the above direction of Northern Regional Committee, NCTE the matter was again placed before the NRC in its 141st Meeting held on **22nd to 24th May 2009** and the committee observes that:

- **The list of appointed faulty as per NCTE Norms has not been submitted till date.**

5. AND WHEREAS Hence, the committee decides to refuse recognition and return **FDR's** if submitted.

6. NOW THEREFORE grant of recognition to **DISTRICT INSTITUTE OF EDUCATION & TRAINING, RAH-E-RAZA, RAMPUR-244901, U.P.** for the course in **BTC Additional Intake** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.

7 If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
