WHEREAS Shri Shivdan Singh Smriti College, Iglas, District- Aligarh, U.P had applied for grant of recognition for M.ED Course of One year (1) duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 31.12.2004.

- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- AND WHEREAS in its 109 (II Sitting) & 110 Meeting of NRC held on 10 November 2006 & 11 to 12 Nov 2006, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied and the committee decided that Recognition be granted to the M.Ed course of one year duration with an annual intake of 25 (Twenty Five only) w.e.f. the academic session 2006-2007 subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/ State Govt./ Affiliating University given effect before the commencement of the course and procurement of more books for the proposed M.Ed Course. Accordingly order was issued to the institution on 14.11.2006
- AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 05.10.2007. After examining it was found that some conditions and requirements have not been fulfilled. Hence a clarification letter was issued to the institution on 05.02.2008. The applicant institution has not submitted the representation to the NRC NCTE. The Matter was placed before the committed and the committee decided to refuse the recognition for M.ED Course and return the FDR's is submitted. Accordingly refusal order was issued to the institution on 24.07.2009.
- AND WHEREAS the above said institution preferred an appeal dated 24.09.2009 to the NCTE, New Delhi Under section 18 of the NCTE Act 1993 against the aforesaid order.
- AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after hearing oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal, set aside NRC's order dated 24.07.2009 and remand back the case to NRC to examine the staff details enclosed to the institution's letter dated 29.06.2009 and take further necessary action. The matter was considered by the Committee in its 156th Meeting and decided to issue a clarification letter to the institution. Accordingly clarification letter was issued to the on 08.03.2010.
- AND WHEREAS the applicant institution has submitted its representation to the NRC NCTE on 31.03.2010. The matter was placed before the committee in its 158th Meeting held on 19th to 22nd April, 2010 and the committee observes:
 - The appointed Professor and Reader do not have qualification as per NCTE norms for M.Ed.

- 9. NOW THEREFORE grant of permission to **Shri Shivdan Singh Smriti College, Iglas, District- Aligarh, U.P** for the course in **M.ED** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
- 10. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
