ORDER

WHEREAS in terms of Section <u>14(1)</u> of the NCTE Act, 1993 Rani Bhagyawati Devi Mahila Mahavidyalaya, Bijnor, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed Course of <u>One year</u> duration with an annual intake of 100 (One Hundred Only) students on 21.11.2005.

- 2. AND WHEREAS the proposal of the above said institution was refused by the NRC NCTE in its 141 Meeting and refusal order was issued to the institution on 25.09.2009. The above said institution, thereafter preferred an appeal dated 21.12.2009 to the NCTE, New Delhi under section 18 of the NCTE Act 1993 against the aforesaid order.
- 3. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT report and after hearing oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal, and reversed NRC's order dated 25.09.2009 with direction to the NRC for issuance of Formal recognition order in continuation of conditional recognition order, in its order no. **F.No. 89-1391/2009 APPEAL dated 12.04.2010.**
- 3. NOW, THEREFORE, in exercise of the powers vested under Section <u>14(3) (a)</u> of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Rani Bhagyawati Devi Mahila Mahavidyalaya, Bijnor, Uttar Pradesh for conducting <u>B.Ed</u> Course of Secondary <u>(Level)</u> of one year duration with an annual intake of 100 (One Hundred only) Students in continuation of conditional recognition order dated 29.12.2006.
- 4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- 5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 6. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
- 7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
- 8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
