WHEREAS, the Aster college of Education, J-1, Sector-9, Silver Oak Estate, Delta-II, Delta, Greater Noida- 201308, District- Gautam Budh Nagar, U.P. was granted permission for running B.ED Additional Intake of two year duration with an annual intake of 200 students vide its office order no. F.NRC/NCTE/F-3/UP-1064/2003/8187-8195 dated 24.01.2004.

- AND WHEREAS, the inspection of the institution was conducted on 01.08.2006 under section 13 of the NCTE Act, 1993. The matter was placed before the committee in its 137th Meeting held on 28th Feb to 1st March, 2009 and the committee decided to issue show cause notice under section 17 of NCTE and comments of the VT report given in the inspection report conducted under section 13. Accordingly show cause notice was issued to the institution on 30.03.2009.
- AND WHEREAS the applicant institution has submitted the representation to the NRC NCTE, Jaipur on 08.04.2009. The original file of the institution as well as other documents and materials submitted by the institution were duly considered by the NRC in its 141st Meeting held on 22nd to 24th May, 2009 and decides to withdrawn the recognition. Accordingly withdrawn order was issued to the institution on 04.11.2009. The above said institution, thereafter preferred an appeal dated 08.07.2009 to the NCTE, New Delhi Under section 18 of the NCTE Act 1993 against the aforesaid order.
- After perusal of documents, memorandum of affidavit and after hearing oral arguments advanced during the hearing, the Council, reached the conclusion that there was adequate ground to accept the appeal and remand back the case to NRC for causing a composite inspection to verify the available infrastructure and instruction facilities for all the teacher training programme i.e. B.Ed (two units) & M.Ed after obtaining a payment of Rs. 40,000/- from the institution and thereafter pass appropriate orders.
- AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
- AND WHEREAS in its 155th Meeting held on 23rd to 25th January, 2010, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the committee decided to issue Show Cause Notice to the applicant institution on 29.01.2010.
- AND WHEREAS the applicant institution has submitted representation to Northern Regional 7. Committee, NCTE on 11.02.2010. The original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were again duly considered by the NRC in its 157th Meeting held on 24th to 27th March and decides:
 - The deficiencies communicated to the Institute through letter F.NO/ NRC/NCTE/ UP-1064/ 155th Meeting/ 2009/15721 dated 29 January 2010 still exist as the reply has not been submitted by the Management.
- 8. AND WHEREAS the committee decides to refuse recognition for B.Ed. course
