WHEREAS R.D.R.B. Mahavidyalaya, VPO- Nathupur Loudhna, Janpad-Ambedkar Nagar, Uttar Pradesh had applied for grant of recognition for BTC Course of tow year duration under section 15(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on 29.12.2004.

- 2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS in its **98 Meeting of NRC held on 22 to 23 December 2005,** the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution and the committee decided to issue a clarification to the institution. Accordingly letter was issued to the institution on 16.01.2006. The applicant institution had submitted its representation to the NRC NCTE on 15.07.2006. The matter was considered by the committee in its 101 Meeting and decided to issue a clarification letter to the institution, accordingly letter was issued to the institution on 17.04.2006. The institution had submitted its representation to the NRC NCTE on 16.05.2006 and the matter was placed in the 104 meeting and the committee decided to issue a Letter of Conditional Recognition to the institution. Accordingly letter was issued to the institution on 26.07.2006.
- 4. AND WHEREAS the applicant institution replied to the NRC NCTE on 30.09.2006. A Recognition Order was issued to the institution on 22.11.2006 subject to the condition to appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/ State Govt./ Affiliating University given effect before the commencement of the course and reminder letter was issued on 06.07.2007. The matter was considered by the Committee in its 141st Meeting and decided to refuse recognition and return the FDR's is submitted. Accordingly refusal letter was issued to the institution on 21.07.2009.
- 5. AND WHEREAS the above said institution preferred an appeal dated 10.09.2009 to the NCTE, New Delhi Under section 18 of the NCTE Act 1993 against the aforesaid order.
- 6. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT Report and after hearing oral arguments advanced during the presentation, the Council reached the conclusion that the case should be remanded back to the NRC for examination of the staff profile submitted by the institution. Accordingly, the Council remanded back the case to the NRC for examination of the faculty profile and thereafter, issuing appropriate order. The matter was considered by the Committee in its 152 Meeting and decided to issue a clarification letter to the institution. Accordingly clarification letter was issued to the on 17.12.2009.
- 7. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE on 29.12.2009. The matter was placed before the committee in its $154^{\rm th}$ Meeting and the committee decided to issue clarification letter to the institution.

The matter was considered by the Committee and decided to issue a show cause notice to the institution. Show cause notice was issued to the institution on 08.03.2010.

- 8. AND WHEREAS the applicant institution has submitted its representation to the NRC NCTE on 29.03.2010. The matter was placed before the committee in its **158**th Meeting held on **19**th **to 22**nd **April, 2010** and the committee observes:
 - The documents required as per NRC/NCTE/UP-1698/ 156 meeting / 2010/ 18269 dated 8 March 2010 have not been submitted.
- 9. AND WHEREAS the committee decides to refuse recognition to BTC course
- 10. NOW THEREFORE grant of permission to **R.D.R.B. Mahavidyalaya, VPO- Nathupur Loudhna, Janpad- Ambedkar Nagar, Uttar Pradesh** for the course in **BTC** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. 3.00 Lakhs in original bearing no. 3595962 and FDR of Rs. 5.00 lakh in original bearing no.056693 are returned herewith.
- 11. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
