ORDER

WHEREAS in terms of Section <u>15(1)</u> of the NCTE Act, 1993 **Jawahar Lal Nehru Smarak Post Graduate College, Maharajganj, Uttar Pradesh,** has submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting <u>B.P.Ed</u> Course of <u>One year</u> duration with an annual intake of **50 (Fifty only)** students on **04.12.2006.**

- **2.** AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.
- 3. AND WHEREAS in its **117**th Meeting, the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution was satisfied that the committee decided to issue **Letter of Conditional Recognition Under clause 7(11) of the NCTE Regulations dated 27.12.2005.** Accordingly Letter of Conditional Recognition was issued to the applicant institution on **11.06.2007**.
- 4. AND WHEREAS, the applicant institution submitted its representation to the NRC NCTE Jaipur on 22.03.2010. The matter was placed before the NRC in its 157 Meeting and the committee decided to issue show cause notice. Accordingly show cause notice was issued to the institution on 12.04.2010.
- 5. AND WHEREAS, the applicant institution submitted its representation to the NRC NCTE, Jaipur on 20.04.2010. The matter was placed before the NRC in its 159 Meeting held on 28 April to 01 May, 2010 and the committee observes:
 - As per the documents submitted by the Institution through its' letter dated 16 April 2010, it is evident that the Institute admitted students in B.P.Ed. course in the 2007-08 and 2008-09 academic sessions. Thus, students were admitted without the approval of NCTE.
- 6. Hence, the committee decides to refuse recognition and return FDRs if submitted.
- 7. NOW THEREFORE recognition to **Jawahar Lai Nehru Smarak Post Graduate College, Maharajganj, Uttar Pradesh** for the course in **B.P.ED** in term of section 15(3)(b) of the NCTE Act, 1993 is hereby refused.
