ORDER

WHEREAS **Savita Devi Girls College, Delhi Road, Vill- Kayasth Gawari, Post- Mohiuddinur, Tehsil- Meerut, District- Meerut, Uttar Pradesh** had applied for grant of recognition for B.Ed Course of one year duration under section 14(1) of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **23.09.2008**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports.

3. AND WHEREAS the Northern Regional Committee after considering the report of the visiting as well as other relevant materials furnished by the applicant institution and the committee decided to issue a Show Cause Notice to the institution. Accordingly letter was issued to the Institution on 07.09.2009.

4. AND WHEREAS the applicant institution has submitted its representation to the NRC NCTE on 25.09.2009. The matter was considered by the committee in its 150 Meeting and decides to issue letter under clause 7(9) of Regulation 2007. Accordingly letter was issued to the institution on 16.11.2009.

5. AND WHEREAS the applicant institution has submitted its representation to the NRC NCTE Jaipur on 11.03.2010. The matter was considered by the committee in its 157th meeting and decided to issue show cause notice to the institution. Accordingly show cause notice was issued to the institution on 12.04.2010

6. AND WHEREAS the applicant institution has submitted its representation to the NRC NCTE Jaipur on 12.04.2010. The matter was placed before the committee in its **158th** Meeting held on **19th to 22nd April, 2010** and the committee observes:

- On the land bearing khasra number 645 another Institution is proposed to be run by the same Management.

7. AND WHEREAS the committee decides to refuse recognition to B.Ed. course.

8. NOW THEREFORE grant of recognition to **Savita Devi Girls College, Delhi Road, Vill- Kayasth Gawari, Post- Mohiuddinur, Tehsil- Meerut, District- Meerut, Uttar Pradesh** for the course in B.Ed in term of section 14(3)(b) of the NCTE Act, 1993 is hereby refused. The FDR of Rs. **5.00 Lakh** in original bearing no. **2715980** is returned herewith.

9. - If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
