WHEREAS Muslima Girl's Degree College, Sir- Syed Nagar, Rehmat Nagar, Karula, Muradabad, Uttar Pradesh has submitted an application to the NRC for grant of recognition/permission for conducting B.Ed Additional Intake of one year duration with an annual intake of 100 (One Hundred only) on 01.09.2006.

- 2. AND WHEREAS the Northern Regional Committee had constituted Visiting Team to visit the institution, which has visited the institute on **06.04.2009** and submitted its report.
- 3. AND WHEREAS the matter was considered by the NRC in its 140 Meeting and the committee decides to issue show cause notice to the institution. Accordingly Show Cause Notice was issued to the institution on 12.05.2009.
- 4. AND WHEREAS, keeping in view the direction of Hon'ble High Court of Delhi in his order dated 12.05.2009 in W.P. (C) 300/2009 to dispose the case by 18.05.2009 and therefore the refusal order was issued on 19.05.2009. The above said institution, thereafter preferred an appeal dated 12.06.2009 to the NCTE, New Delhi under section 18 of the NCTE Act 1993 against the aforesaid order.
- 5. AND WHEREAS, after perusal of documents, memorandum of appeal, affidavit, VT Report and after hearing oral arguments advanced during the hearing, the Council reached the conclusion that there was enough ground to accept the appeal, and set aside NRC's order dated 19.05.2009 and the remanded back the case to NRC for examination of the file in totally taking into account the reply to the show cause notice and thereafter pass appropriate order.
- 6. The matter was considered by the committee in its 152^{nd} Meeting and the committee decided to issue a clarification letter to the institution. Accordingly clarification letter was issued to the institution on 17.12.2009. The applicant institution had submitted the representation to the NRC on 27.01.2010 & 28.01.2010.
- 7. The matter was considered by committee in its 157 Meeting and the committee decided to issue letter under clause 7(9) of Regulations 2007. Accordingly letter under clause 7(9) of Regulations 2007 was issued to the institution on 12.04.2010. The applicant institution had submitted the representation to the NRC on 26.04.2010.
- 8. AND WHEREAS the original application submitted by the institution, Norms and Standards, Rules and Regulations & NCTE Act were placed before the **Northern Regional Committee** in its 160th **Meeting held on 18th to 20th May, 2010** and the committee observed the followings:
 - The NAAC certificate has not been submitted.
 - The documents related to qualification and experience of HOD and Faculty have not been submitted.

Hence, the committee decides to close the file.
